Mintabie Progress Association this week from AHAVA Energy, holder of a Petroleum lease over the Mintabie town outlined that water tests recently done by the company showed that the water at the Mintabie Road Bore was unfit for human consuption and also for use.

Lee Craggs said, that Director of AHAVA Energy Mr Djonny Suwanto's letter stressed the importance of not using the water. As a consequence of AHAVA Energy's independent test results the company had obtained, Mr Suwanto instructed Welbourn Hill Station owner Donald Sampson to lock the bore in order to prevent it being accessed by

The Coober Pedy Regional Times spoke with Mr. Djonny Suwanto of AHAVA Energy on Tuesday who said, "we are unable to release the results of the water tests, however we have sent the test results to the Environmental Protection Authority (EPA) and they are the correct people to publish the information contained in the report".

Correspondence sent to Lee Craggs, Chairman of Mr. Suwanto said, "we have put up signs in English and in the local languages to hopefully prevent people from drinking or using this water."

> Further to this, Lee Craggs said he was handed a note by the local publican which had been left for him at the Mintabie Hotel. Mr. Craggs said the handwritten note was not signed, however stated in essence:

'Bore on main road which was for Mintabie - samples taken + checked. Full of Ecoli and Uranium and other heavy sh*t. Not fit for human consumption or cows."

The Mintabie Chairman said he has now written for the third time to Water Minister Paul Cacia since his correspondence to the Minister on Tue 21st Dec 2010 and Tue 4th Jan 2011, stating that "the situation in Mintabie has escalated even further."

"We are now running Town Bore (our final and failing bore) approx 21 hours per day to supply Mintabie Township's restricted needs." Continued page 3


Francene now operates Francene Connor & Associates, which provides marketing and public relations advice to a range of clients in the private and public sectors in Adelaide.

Mintable pleads with state government for water assistance

Lee Craggs reiterated in his letter to Minister Cacia, "As advised on the 4th Jan 2011, The Mintabie Miners Progress Association (MMPA) reduced available water to each residence by 33% down to 480 litres per day, and will have to reduce that level to 50% IE; 360 litres per residence per day, or even lower any day now.

We have had our meeting with the Bureaucrats your department sent up to us on the 17th Jan 2011. Very little was achieved during these negotiations, purportedly held to resolve our long or short term water supply issues, but seemed rather more intent on solving the problems of their publicity-shy political bosses.

The Bureaucrats were informed of the MMPA's proposed emergency water supplementary plan to road transport non potable water from a nearby DTEI owned bore 15klm East of Mintabie into the Mintabie Township storage facility, until a permanent supply could be sourced but would not commit to fund this proposal and still have not.

Mr. Craggs advised Minister Cacia of the tests conducted by Ahava Energy stating:

"MMPA as a stakeholder in all of this, attempted to get copies of the recent test results for the DTEI bore and Town Bore but were denied by AHAVA ENERGY.

PIRSA had been in touch with Mr Yami Lester (Walatina Station) securing "Apamurra Well" 6 klm North of Mintabie, to use as a permanent supply of water to Mintabie Township (their plan).

In the interests of forward planning the MMPA have already had talks previously with Mr. Yami Lester on two occasions (the most recent 18 months ago) with regard to using Apamurra Well as a backup supply if needed. But this proposal was declared by MMPA to be unviable because, anecdotally this bore (age and condition unknown) has always been a windmill bore (approx 200/300 ltr per hr) and had pumped dry in the past and eventually even the cattle refused to consume the water from it due to the ocean like levels of salts and minerals.

Apamurra Well will never be able to supply the volume (5000 ltr per pump hour) or quality of water needed to supply a township the size of Mintabie. (100 houses and 150 people)

The document named "Mintabie Water Supply Needs Assessment" dated October 2005, was unseen by anyone on the MMPA Committee until it was recently uncovered by myself on the 13th Dec 2010.

Some of the Assessment Report's recommendations were that 2 additional bores be equipped, UV disinfection of the water and the town's water storage system be upgraded in 2005, and nothing was done over this period!

We were told at the 17th January 2011 meeting that 2 applications to the Govt for funding had been made but were unsuccessful. What happened during the 260 weeks following that?

This document, "Mintabie Water Supply Needs Assessment", has lain hidden and ignored by the OACDT for 5 years. Mintabie Township would not be in this crisis if stages 1a, 1b & 2 clearly out-lined in this report had been implemented (costed at \$490,000) then.

I feel heads should roll over this act of bastardry. Macquarie dictionary defines bastardry as "an act of obnoxious and unpleasant behaviour". No excuses can forgive the perpetrators for their total lack of action on the "Mintabie Water Supply Needs Assessment and the vitally urgent recommendations contained therein.

As stated to the Govt representatives at the 17th Jan meeting, the MMPA committee has worked diligently over the last 18 months to reduce Mintabie Township's water consumption by almost 40%, and had spent nearly \$6000 in materials funded from community contributions, free of labour costs as we are all volunteers.

We have cut off supply to all outlying and abandoned areas of the township, turned off supplies to camps temporarily unoccupied, replaced pipelines that were suspect, spoken to all residents encouraging water saving measures and minimising their consumption, as any responsible management body would promote. These action have consumed 100's of unpaid man hours due to lack of Govt funding.

The Govt Ministers and Bureaucrats need to understand that the water supply to Mintabie Township was designed by amateurs, Built by amateurs and Run by amateurs, (all unpaid volunteers) on a shoestring budget, with minimal Govt support and without training.

The State Govt, through the OCA currently contributes only \$2.18 per hour towards our town's water supply costs. All diesel and consumables are funded from the community's contributions to the MMPA

High Grade Magnetite Intersected at Cairn Hill Phase 2

Iron ore producer, IMX Resources Limited is pleased to announce that high grade massive magnetite was intersected in the initial three reverse circulation (RC) holes drilled at Cairn Hill Phase 2 (CHP2) in South Australia.


The holes were drilled immediately east of the current Cairn Hill Phase 1 mining in the CHP2 area where magnetite only mineralisation is present. An intense magnetic high that was interpreted to be a wide pod of magnetite mineralisation was targeted by the initial 241m of drilling (Figure 1). Analytical results confirm that between 9 and 22m of massive magnetite was intersected by the drilling.

The 7,000m RC resource drilling programme commenced at CHP2 in late 2010 and recently resumed. Two RC drill rigs have been contracted to complete the programme with one currently onsite, and a second delayed due to the recent

flooding in Queensland. This second rig is expected to arrive in the next two weeks.

In addition to the RC resource programme, a diamond drilling programme is planned to obtain sufficient representative whole core samples for bulk dry magnetic separation testwork as part of the CHP2 metallurgical programme.

The Phase 2 area is a low copper / sulphur magnetite with generally a slightly lower iron grade than the Phase 1 area that IMX is currently developing. Initial metallurgical testwork results in 2008 were very encouraging and confirmed it is possible to produce a 60% Fe intermediate magnetite concentrate through just dry magnetic separation or a premium quality 69% Fe magnetite concentrate through dry and wet magnetic separation with very low levels of impurities at an exceptionally coarse grain size of 0.5mm (ASX: 8 September 2008).

Workzone Traffic Speed Restrictions

Recently Council's Water Supply Department was faced with an emergency water leak from a mains water supply burst on Hutchison Street. During the repair work it was noted that on two occasions, traffic restrictions that were enforced (25 kph speed limit and 'Road Closed' signs, were totally ignored and could have resulted in severe injury or worse for Council employees.

Public road users were also noticed going around signs or climbing kerbs to avoid road signs, in addition to traversing and parking along and in the work zone area.

Speed restrictions and detours are put in place not only to protect the site workers, but also to protect the public from dangers incurred by the works undertaken. Mintabie pleads with state government for water assistance

The largest consumer of water from Aboriginal students to Mintabie the township's supply would be the Mintabie Area School, which will be resuming activities for 2011 in the next few days.

The school and teacher's residences has 9 or 10 evaporative coolers which use up to 1000 litres per day each (the Govt's estimate). That's 10 tonnes of extra water per day we have to provide from our rapidly dwindling supply.

The OCA is about to start a Govt funded project here at a cost of \$50 to \$60,000. This new project will install automatic solar powered lighting to Mintabie's unused airstrip (that amount of money would pay for 2 new bores). The Flying Doctor doesn't land here anymore, preferring Marla airstrip after Mintabie's clinic was shut down due to lack of Govt funding.

All Mintabie residents now have to travel to attend the Marla Medical Clinic, which entails an 80 klm round trip, on a rough dirt road that hasn't been graded since July last year, even after damage from 6 significant rain events, due to lack of Govt MMPA begged them to. **funding**. This forgotten road is the school bus route, carrying 10 or 12

Area School. Some students travel up to 400 klm per week, in all weather conditions on this poorly maintained road.

Now the population here has reduced due to lack of Govt **support** for facilities, leaving many aged pensioners, some penniless, trapped after health or financial bad luck, reduced to a point that it is impossible for the handful of able bodied volunteer residents to continue to maintain the service that the State Govt supplies to every other community in the state.

Many smaller towns like William Creek and Innamincka only have 5 or 6 people and are no less remote than Mintabie and have their water supplies run by the

On the 6th Dec 2010 the OCA took Copley communities water supply off them, without the Copley Progress Association or resident's knowledge, but refused to take over Mintabie's even when the

KEEPYOURKIDSLUNCHBOX SAFEDURINGHOTWE

As school returns this week, SA Health is reminding parents to keep their children's lunches safe from food poisoning.

SA Health's Director of Food Policy, Dr Fay Jenkins said, there are a few simple steps that parents can follow when preparing their children's lunches to avoid possible food poisoning.

"Food that is stored in a warm lunch box or bag for several hours can reach temperatures that are ideal for bacteria to multiply", Dr Jenkins said.

Bacteria can grow on foods such as chicken, fish, meat, yoghurt, soft cheese, milks, cooked eggs and salads.

"You can avoid this by placing an ice block or pack in an insulated lunch box to keep foods cold until lunchtime.

"Or you may prefer to freeze single-serve juice boxes overnight and place them in the lunch box. The juice will thaw by lunchtime, but will still help keep the rest of the lunch cold.

'Many people do pack sandwiches or crackers with spreads like VegemiteTM and jam and these are not so susceptible to going off in the heat. Healthier alternatives parents might like to consider are whole uncut fruit and vegetables, such as carrot and celery sticks or, for older children who can open them, safely tinned fish products.

· Wash lunch boxes with hot, soapy water and dry before re-use.

If lunches are made the night before, keep them in the refrigerator overnight.

· Any perishable food, such as meat, poultry or egg sandwiches, should be

discarded if not eaten that day.

· Discourage children from swapping lunch items with their friends as they may have food allergies.

Nicotine patch subsidy to help moré

Low income earners in South Australia have even more support to quit smoking from today with subsidised nicotine replacement therapy (NRT) now available to concession holders.

Quit SA is urging people who are eager to use NRT to act now in the best interests of their health.

"This is another tool in the armoury against smoking that will only cost concession holders \$5.40 for one months supply – compared to the \$140 or so it would have cost before today," says Quit SA Manager, David Edwards.

"That's a lot cheaper than the ongoing financial cost of more than \$6,000 a year for the average pack-aday smoker – let alone the health implications of not quitting."

Quit SA hopes the change will motivate a new wave of quitters, who can also receive additional free support from Quitline 13 7848 or through our interactive text messaging support, Quit onQ.

"Smoking is no longer a habit 80% of the population choose not to practice -; it's becoming unsustainable for the 20% who do - when you couple the deadly impacts with the recently increased hit on hip pockets," says Mr Edwards.

"The Government's re-investment of tobacco tax revenue, by subsidising NRT through the Pharmaceutical Benefits Scheme, will inevitably prove a strong motivator."

People on income support smoke at much higher rates than those who are more financially meaning they will bear a disproportionate share of associated health concerns.

NRT can increase a smoker's chance of quitting by more than 50 per cent.

If you're a working parent expecting a child, there's something else you can expect

On 1 January 2011, Australia's first national Paid Parental Leave scheme was introduced. It's a new entitlement for working parents, funded by the Australian Government.

Taking time away from work for a new baby is a common part of working life. Paid Parental Leave will help parents spend time with a new baby, and help employers retain skilled staff.

What is Paid Parental Leave?

Eligible working parents may get 18 weeks Government-funded pay at the National Minimum Wage, currently \$570 a week before tax, to help them care for a new baby. Parents who adopt may also be eligible.

Am I eligible?

Full-time, part-time, casual, seasonal, contract and self-employed workers may be eligible. You must have worked at least 330 hours (just over one day a week) for 10 of the 13 months before your new baby arrives. You can have

up to an 8 week unpaid break between two working days and still be eligible. You can earn up to \$150,000 a year (individual salary) and still be eligible.

Is it for both parents?

Yes, usually the mother must apply for Paid Parental Leave. If you are eligible, you can transfer some or all of the pay to your partner (they need to be eligible too). The scheme gives families more options to balance work and family.

When can I take it?

You can claim up to three months in advance, and your pay can start at any time you choose from when your child is born or adopted. It will be paid in one continuous period from the start date and must all be taken within the first year after the birth or adoption. You are encouraged to apply early.

What about employer-provided entitlements?

Eligible parents can receive Parental Leave pay at the same time, before or after other employer-provided paid leave or entitlements. The existing minimum entitlement to 12 months unpaid parental leave for long-term employees is unchanged.

What does it mean for employers?

From 1 July 2011, employers must provide Government-funded Parental Leave pay through their usual pay cycle to eligible employees who have been with their business for at least 12 months. Other eligible parents will be paid through the Family Assistance Office.

STATE OF THE **NATION SOUTH AUSTRALIA**

Excerpt from The Australian by Michael Owen -29 January 2011

TREASURER Kevin Foley is predictably dismissive about a gloomy report card by leading economic forecaster Access Economics.

The quarterly report on business outlook released this week said the state's much vaunted mining boom was yet to arrive and manufacturers were doing it tough.

The latter point was driven home by paper giant Kimberly-Clark's decision to slash 170 jobs in the state's southeast, with another 65 to go if a buyer cannot be found for an unwanted pulp mill.

Access Economics also reported that exports to the US, Britain and Europe were falling at doubledigit rates and the same was true of exports of wine and (the even harder-hit) cars and car parts.

It further noted that unemployment had moved back above national rates (and the gap is increasing), business investment is fading to levels last recorded a decade ago, and federal stimulus spending (a big positive in a small state) is expected to wind down over the next year or so.

OODNADATTA TEMPERATURES SOAR BUT LOCALS STILL CELEBRATE

Despite the heat on Sunday 23 January outback residents got together at the Pink Roadhouse to socialise. It was also local resident Ross Fields birthday.

January 2011 has seen unrelentlessly high temperatures ranging from the mid to high 40s, the highest this year being 47.5 C, on the 27 January at Oodnadatta. The remote town has also reached above 45 degrees for five consecutive days which ties it's 60 year record.

Oodnadatta recorded Australia's highest temperature on the 2 January 1960 when the outback town experienced a remarkable 50.7 C.

In the same week Oodnadatta's mercury reached 49.2 C on the 1 January 1960 and 50.3 C on the 3 January 1960.





MINTABIE PLEADS WITH STATE **GOVT FOR WATER ASSISTANCE**

"The responsibility for managing these essential services belongs to the State Government, NOT a volunteer Progress Association . That would be like putting the local footy team in charge of your hospital. We admit freely - we do not have the expertise, knowledge or training to perform these responsible and accountable duties to the level that is required in this litigious society.

The MMPA in the last few days, has had to cut supply from one customer who has not only refused to pay his Town Services Levy for years, he has also drilled out his water restrictor, enabling him to take huge amounts of water for long periods on more than one occasion. The last time was on 20th Jan this year, while the rest of the community here was doing it very hard without complaint, and accepting the current water restrictions. This man is extremely upset and blaming me (the MMPA President) for all his woes, previously threatening me with shooting, blowing up my house and vehicles as well as bulldozing the township's water infrastructure.

No volunteer should have his life unnecessarily put at risk while performing his duties. Volunteer paramedic / ambulance drivers, fire-fighters or SES members etc aren't allowed to do anything that threatens their life, as their organisations have a duty of care towards them.

The Govt is patently neglecting their basic duty of care to the residents of Mintabie, taking advantage of those who have freely volunteered to perform tasks outside their field of experience, knowledge and training, so that this Govt can save a few dollars for their own pet projects.

S.A. Transport Minister Conlon spent \$490,000 of our tax-payer money refurbishing his office recently. That money would have solved Mintabie's water problems for many years! Mintabie residents find this extremely offensive!! People's basic needs before furniture!!

My wife and I came here nearly six years ago, spending almost \$100,000 of our life savings to get here. She was suffering significant depression, and had hoped to recuperate in a nice quiet outback town like Mintabie. She had a doctor's certificate for eight months and a health care card to access the subsidized medications needed for her recovery.

However because she moved to Mintabie. Centrelink cancelled her healthcare card, stating there was no work available in this town so she wasn't eligible to have one. I argued that she couldn't work for at least eight months as she was ill, but they wouldn't listen and refused to give her the medications at the reduced rate forcing us to pay the full price which was nearly \$400 per month. (almost a house payment for some). By not funding her medications, she came off them much sooner than recommended, leaving her a little more fragile than some. Combined with the threats we are receiving as volunteers from a selfish, and volatile person in this community, I fear a return of the "Black Dog".

Some say we should pack up and leave, this is a simplistic solution. Our properties resale has been made worthless, essentially trapping us here by a stroke of a politicians pen when the Parliament of SA passed laws on the 3rd Dec 2009, banning us from cooking with, or drinking alcohol in our own homes. Everyone will now also have to have a police check to prove our innocence and good character, before being allowed to live here. Visitors must be named, prior to visit, to PIRSA and then may only visit if approved.

Just like any other part of Australia NOT!!!

Because of these laws, and the lack of Govt support that all other SA communities receive. our family home and assets here have been made monetarily worthless. No prospective resident will choose to live in Mintabie now.

The residents of Mintabie pay Camp-Site Fees to the APY via Pirsa, Prospecting and Mining fees to PIRSA, a Town Services Levy to the MMPA, Income Tax and GST to the Govt.

Why shouldn't residents expect the same services that all other communities receive from the Govt. Instead are ridiculed, denied and abandoned by our State Government representatives.

The largest asset most Australians have is their home. Our assets have become liabilities because we cannot just surrender our camp-sites to PIRSA and leave.

All Mintabie residents are now required to return the camp-site back to the condition prior to the settlement of Mintabie. ie; must raze the campsite to the ground before PIRSA will allow us to leave, to start again somewhere else, minus the funds from the sale of our home......

Or else PIRSA will do the razing for us then charge each resident for the privilege. This condition, among others, was not stated when PIRSA accepted camp-site ownership transfers and monies.

The residents of Mintabie, desperately need you, and your people, to make some sensible and responsible decisions. urgently! Accept your basic duty of care to us. Please treat Mintabie residents the same as other South any Australian."





SA business confidence remains low - labour costs expected to rise

Business confidence has remained low during the December 2010 quarter, according to Business SA.

Business SA Chief Executive Officer, Peter Vaughan, said that the survey results confirm that pressure remains on business.

"Challenges still remain throughout the local business community and the interest rate rise, coupled with concerns over financial stability in Europe, deterred any significant bounce back in confidence in December.

"The local economy has been faced with high unemployment and slow retail trade, making November's rate rise more damaging and speculation of future interest rate rises continuing to restrict confidence.

"Almost 70 per cent of businesses expect interest rates to increase in the next quarter and this is a major concern given the many small businesses across the State that are struggling to build any sort of momentum," said Mr Vaughan.

Mr Vaughan said that businesses expect labour costs to continue to rise.

"Our local unemployment remains above the national average and almost three quarters of businesses surveyed expect labour costs to increase in the March quarter.

"A quarter of businesses found skilled labour harder to source than the previous quarter, however nearly a half expect the unemployment rate to remain steady in the March quarter.

"Indications are that overhead costs will again increase next quarter, while half expect the cost of materials to remain the

Every year around 700,000 baby calves (commonly called 'bobby calves') are slaughtered in Australia as waste products of the dairy industry. Mother cows would normally suckle their young five times a day. If passed, this standard will compound the misery and suffering endured by hundreds of thousands of unwanted bobby calves each year.




